CORRIGENDUM I

1. Total non-refundable bid processing fee for the project is Rs. 11,80,000 (Indian Rupees Eleven Lakhs Eighty Thousand Only) (inclusive of GST) if the Bidder is an Indian entity, or USD 14,286 (Fourteen Thousand Two Hundred and Eighty Six) plus applicable taxes if the Bidder is a foreign entity.
